Reimbursement basis for this **Add On** cover bills incurred for hotel accommodations, treatment, related testing, in respect of the quarantine.

This benefit is to be added on and applicable on a per individual and per **Trip** basis. The period of cover where this **Add On** is applicable is from <*date Trip begin*> to <*date Trip end*> based on **Your** declaration at the time of purchasing this **Add-On**.

PROVISO

This benefit is only payable if **You** are:

SPECIFIC DEFINITION

Overseas shall mean beyond the territorial limits of Malaysia and not the **Insured Person's Home Country**.

 - (A). Medical treatment for **Hospitalisation** directly arising from COVID-19 infection and costs incurred while **Overseas** as provided in Sub Section 3.1;
 - (B). Emergency Medical Evacuation as provided in Section 8;
 - (C). Repatriation as provided under Section 9;
 - (E) Trip Curtailment as provided under Section 12.

Benefit (A) will provide indemnity for **You** for the cost of **Your** Medical treatment for COVID-19 infection incurred by **You** in a **Hospital** registered under the laws of the relevant **Overseas** jurisdiction on reimbursement basis and shall be subject to the sub-limit and the **Maximum Aggregate Add-On Limit** mentioned in the Table of Benefits above and as provided for in Sub Section 3.1 of this **Policy**, according to the Plan **You** purchased.
